VENTURA COUNTY BEHAVIORAL HEALTH (VCBH): Behavioral Health Worker Practicum FACT SHEET

VCBH is part of the Ventura County Health Care Agency's integrated public health care system which includes Ventura County Medical Center, Santa Paula Hospital, Ambulatory Clinics, Public Health, Emergency Medical Services, and the Medical Examiner's Office.

The Ventura County Behavioral Health Department provides a system of coordinated outpatient services to meet the mental health and substance abuse treatment needs of Ventura County. Services are delivered from regionally based Behavioral Health Centers for children and families, adolescents, transitional aged youth (ages 18-25), adults, and seniors. Specialized services are also provided in partnership with city and county agencies, courts, local law enforcement, schools and community-based coalitions.

Behavioral Health Worker Practicum

The practicum program, offered by VCBH, is dedicated to providing comprehensive training opportunities for students enrolled in Substance Abuse Counseling programs. The practicum provides comprehensive clinical experiences, excellent supervision (by supervisors who meet regulatory agency supervision requirements) and supplemental seminars and workshops. Students are assigned to an outpatient mental health program as a Behavioral Health Worker intern (based on interest and availability) and rotate through Substance Use Services programs to ensure exposure to the 13 Competency Domains for Substance Abuse Counselors.

Substance Use Services Programs

New Start for Moms: Comprehensive day treatment program and outpatient counseling to pregnant and/or parenting women that are using alcohol and/or other drugs.

Alcohol and Drug Treatment Centers: Outpatient centers that provide assessment, treatment, crises intervention, and referrals for alcohol and other drug abusing adolescents, adults and their families.

Driving Under the Influence Program: Educational program for persons referred by the Court, Probation or the California Department of Motor Vehicles. This program provides information, counseling, and support system to modify attitudes/behaviors related to alcohol and other drug abuse.

Forensic (adolescents in the juvenile justice system): Alcohol and other drug assessment and treatment provided through the mental health juvenile justice program.

Alcohol and Drug Prevention Division Utilizes environmental/public policy prevention initiatives and education to prevent underage and binge drinking, impaired driving and

FREQUENTLY ASKED QUESTIONS

What type of experience would I gain?

Your caseload and specific experiences are based on the assigned program and current skill level. Typical responsibilities might include screenings, intakes, group counseling, conducting educational groups, targeted case management, providing referrals, and completing case write-ups. Observations in the Substance Use Services Division will include exposure to the 13 Competency Domains for Substance Abuse Counselors.

All activities are supervised by a mental health professional employed by the department. The supervisor meets with the intern on a regular basis. BH Workers Interns also attend a monthly 2-hour supervision/training session in addition to the supervision received at the clinic site. During these sessions, a variety of topics are covered such as case management skills, legal and ethical issues, self-care in working with mentally ill population, motivational interviewing concepts, confidentiality laws and basic CBT concepts.

Hours rotating in SUS programs are supervised by a CAADAC or CAADE certified professional employed by the department. This supervisor oversees the student's work responsibilities and provides individual supervision. Depending on the program, students might also participate in group supervision and treatment team meetings, with students from other clinical disciplines such as psychologists, marriage and family therapists, social workers, or art therapists.

Is there an orientation for the internship?

Orientation is provided during the first 4 weeks of the internship. This includes a general overview of the department and training is provided on a variety of topics such as cultural competency, confidentiality, documentation, working with mental health clients, safety protocols and legal/ethical guidelines.

What are the requirements to participate in a practicum with VCBH?

All students must have completed the minimum pre-requisite courses in an Addictive Disorders Studies/ Substance Abuse Counseling program and be currently enrolled in a field experience course in a school with which VCBH has an active Memorandum of Understanding.

Is there a required time commitment and when does the practicum begin?

VCBH requires a 2-semester commitment and a minimum of 8 hours per week --

120 hours per Semester (unpaid)

Internships typically begin in January and end in December. Most of the clinic sites are open Monday - Friday 8:00 am to 6:00 pm, with some evening hours available. The internship hours are completed during hours of operation. Your specific schedule is based on the requirements of the individual clinic or program, with consideration of your school schedule and personal preferences. You will discuss a proposed weekly schedule during the interview process and finalize it with your supervisor once you have been accepted into the program. The initial weeks of the internship may require attendance on days that are different from your regular schedule, due to the orientation schedule.

How do I apply for a practicum?

You will need to complete the Student Internship Application - Behavioral Health Worker. Submit this form with a copy of your recent transcript and one letter of recommendation. This application packet is submitted to the Training & Workforce Development Program for initial review and then qualified applications are forwarded to the appropriate program staff. An interview is then scheduled.

What is the time frame for the application and interview process?

Applications for the 2022 calendar year cohort will be posted by September 2021. Completed applications will be due by October 22, 2021. Interviews and placements will be offered in November 2021.

What types of questions will I be asked during the interview process?

You will be asked questions that relate to your interest in mental health and alcohol and drug treatment, any prior experience and current skill level. You will also be asked about your time commitment and what you hope to gain from an internship with VCBH. During the interview you are encouraged to ask questions about the program to determine if placement within VCBH would fit your educational goals.

Can you provide more information about the background clearance?

Students must complete a background clearance as required of all employees, volunteers and students. Generally, students that have background issues that indicate a potential threat to any consumers or staff would not be accepted. The County of Ventura conducts an individualized analysis, considering such factors as the nature of the job, severity of and length of time since the offence. An applicant would not be accepted into the internship program if he or she is receiving services from the department as a current client (as that would be a conflict of interest and dual relationship) or has current outstanding legal matters to resolve. If you have any questions about this or have any reason to think you might not clear a background check then you should contact the Training and Workforce Development Department in advance to discuss your situation.

Students must complete a TB clearance, prior to the start of the practicum, which can be conducted by the student's personal physician or can be arranged through the County's employee health services department. Students must also have proof to having vaccine records or blood titer test results for Varicella IgG, Rubella IgG, and Rubeola IgG demonstrating immune titers from previous vaccination since, these are airborne. Titer and vaccination is also available through the County's employee health services department. During flu seasons all staff and students are required to get a flu shot. There is no cost to the student when using the County's employee health services department for these purposes.

The background clearance, TB and vaccine clearances and flu shot are provided at no cost to the student.

Are there any other requirements?

Students are expected to carry student malpractice insurance - this is usually met by submitting a certificate of insurance from their educational institution. Evidence of insurance coverage must be provided to the Training and Workforce Development Department at the beginning of the practicum and before providing client services.

Is there a stipend provided for practicum positions?

Currently, there are no stipends available for the Behavioral Health Worker Practicum. You will, however, receive a wealth of experience, excellent supervision and supplemental seminars that are invaluable to your professional development. A certificate of Practicum Completion is earned at the completion of 2 semesters of field experience which serves as verification of work experience to be used when applying for future employment. Note: while we wish all our students success on their professional journeys, all Ventura County Hiring Rules and Regulations Processes are in effect when applying for any future County Employment possibilities.
